Ortaklığımızın çıkarılmış sermayesinin 254.140.000 TL'den 318.000.000 TL'ye çıkarılması nedeniyle artırılacak 63.860.000 TL nominal değerli 63.860.000 adet B Grubu pay ve mevcut ortak Fuzul Holding Anonim Şirketi'nin sahip olduğu 28.000.000 TL nominal değerli 28.000.000 adet B Grubu pay olmak üzere toplam 91.860.000 TL nominal değerli 91.860.000 adet B Grubu payın halka arzına ilişkin duyurudur.

Ancak İzahname'nin ve işbu Duyuru'nun onaylanması söz konusu belgelerde yer alan bilgilerin doğru olduğunun Kurulca tekeffülü anlamına gelmeyeceği gibi, sermaye piyasası araçlarına ilişkin bir tavsiye olarak da kabul edilemez.
